This data is stored purely for technical reasons and cannot be linked to any individual person. We are not combining the website log data with any other information about you. Such website logs are retained for a period of 30 days after which only the aggregated usage statistics, which cannot be connected to a single user remain. Everything else will be deleted.

Application data

On a voluntary basis you may further add a telephone number, a cover letter, additional documents, as but not limited to certificates, a website and additional information about you.

We are collecting and processing those data for the sole purpose of managing Eyeo's recruitment related activities as well as for organizational planning purposes. Consequently, Eyeo may use your personal data in relation to the evaluation and selection of applicants including for example setting up and conducting interviews and tests, evaluating and assessing the results thereto and as is otherwise needed in the recruitment processes including the final recruitment.

Do we disclose any Personal Data?

We will not transfer your personal data to third parties as a matter of course without letting you know in advance or asking for your prior permission. We may only transfer your personal data to third parties without informing you separately beforehand in the following exceptional cases as explained below:

- If required for legal proceedings/investigations, personal data will be transferred to the criminal investigation authorities and, if appropriate, to injured third parties. We will only do this if there are concrete indications of illegal and/or abusive behaviour. We are also legally obliged to give certain public authorities information. These are criminal investigation authorities, public authorities which prosecute administrative offences entailing fines and the German finance authorities.
- For job application we are using an external service provider to provide online application for you. Information is transferred to ENABLEAN Consulting GmbH & Co. KG, which provides the application tool TalentsTracker, in order to enable them to fulfil their contractual obligations. We have carefully selected this external service provider and review regularly to ensure that your privacy is preserved.
